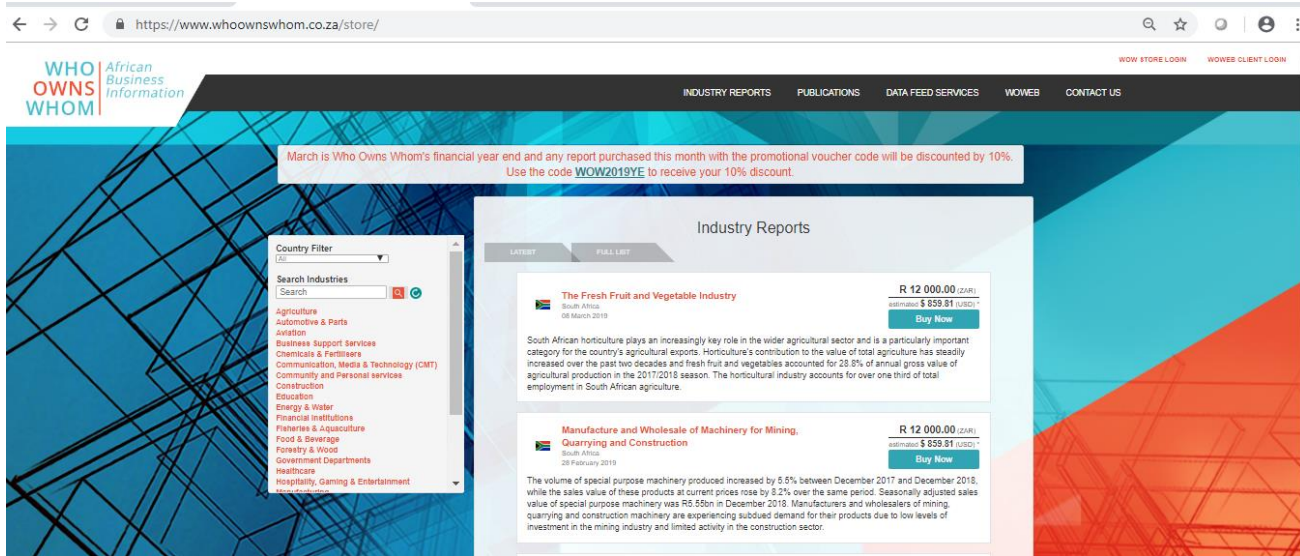
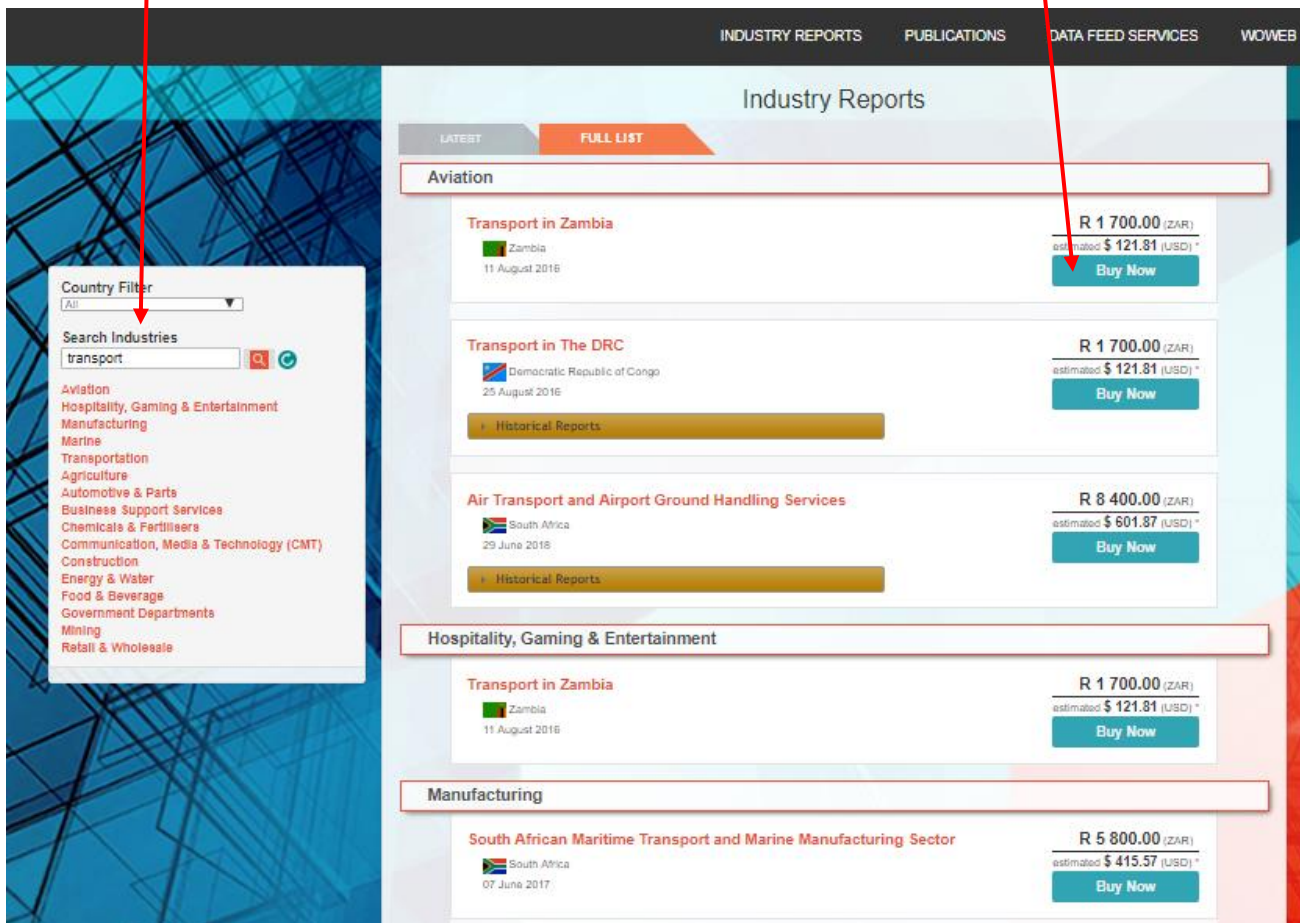


# How to buy a Who Owns Whom Industry Research Report:


**Step 1:** Visit the Who Owns Whom online store at <https://www.whoownswhom.co.za/store/>:



**Step 2:** Search for the Industry Research Report you are interested in and click "Buy Now":


